Superintendent Search: Mr. Hardy, MASC (Taken out of Order):

Mr. Hardy provided the School Committee with the formation and names of the 13 members who have volunteered to serve on the Superintendent Search Committee as follows:

- 2 School Committee Members: Erin DeStefano and Jim Killion
- 2 Building administrators with one from each building: Susan Gilson and Lisa Mobley
- 2 Teachers (chosen by the KPTA with one from each building): Doris Brennan and Katie Brenneis
- 1 Special Education: Connie Eckart
- 1 Director of Finance: Larry Azer
- 2 Parents (one from the MS and one from HS): James Caprarella and Dawn Martin
- 2 HS student representatives: Jack Carr and Tyler DiFiore
- 1 Town Representative Jennifer Thompson, Town Administrator of Plainville

Mr. Hardy described the work that will be entailed of the search committee to review 37 applications in preparation for interviews and recommended presenting back to the school committee no less than 3, no more than 5 qualified candidates that the search committee is comfortable with. Following discussion, the committee would like to see 3 to 5 candidates, but would prefer 5. The schedule is to interview the candidates during the first 2 weeks in February. Mrs. McEntee noted that she will not be available on February 5, 2018.

A Motion was made by Mr. Gee, seconded by Mrs. McEntee, to appoint members of the Superintendent Search Committee as presented. They will be charged to review and present back to the School Committee no less than 3, no more than 5 qualified candidates. All in favor. Yes (7); No (0). Motion carried.

Mr. Francomano thanked the members of the committee for their time to find a successor candidate.

Mr. Francomano indicated that he received an email from Dr. Allardi, Norfolk Superintendent who indicated that she could not attend as part of the search committee, but asked if the finalists speak with the elementary districts as a focus group. The School committee and Mr. Hardy agreed that this would be a good idea.

Dr. Mobley presented the addition of AP Music Theory course description that requires a 2nd reading.

COMMUNICATION:

- Appointments, Retirements, Resignations, etc. were presented in a memorandum from Dr. Zielinski dated January 8, 2018.
- Approved Minutes of the Finance Subcommittee dated: 11/22/17 and 12/8/17.
- Dr. Zielinski applauded the custodial crew for removing the snow during the recent snow storm.
- A Memorandum from Dr. Gilson dated January 3, 2018 regarding the Community Survey Strategic Planning Working Group Update that was read into the Minutes by Mr. Francomano:

Thanks to all in our community that responded to the district efforts to conduct a Community Survey as a part of the District Strategic Planning Working Group. The survey was designed to gather constructive feedback about community perception of how we are doing in the areas of: Budget, Curriculum, Technology, Student Safety and Wellness, Athletics, Music, and Student Activities. It was opened November 7, 2017 and extended through December 17th, 2017. During that time, the district collected approximately 800 responses from across our community of Norfolk, Plainville, and Wrentham. Of these responses, about 58% of those responding were current King Philip School District Parents. Other respondents included current elementary school parents only (20%), former KP parents (11%), and other community members (11%).

The Strategic Planning Committee will be resuming their meetings again in January for the purpose of data analysis of community survey results. We expect that some additional focus groups will be conducted in late January/early February to gather additional information about the areas surveyed.

To complement the community survey, the group is planning on conducting both a staff survey and a student survey. Results will be released later in the spring and will be used as a guide for future district planning.

Discussion ensued that the Community Working Group (CWG) Advisory Committee met last week and is looking at it as an opportunity as to how the school committee is performing and at the same time looking for our input. Currently the CWG is reviewing the survey responses and talking about where they are going next and want to be active in the 3 towns and serve as an independent voice on the district's budget and performance. The CWG would like to come before the School Committee and discuss the journey so far and where they are going and perhaps provide recommendations.

Mr. Gee concurred and included that the CWG may want to present some data they have been processing at an upcoming meeting in February. Upon discussion, Mr. Francomano will add to the agenda a CWG presentation on February 5, 2018.

UNFINISHED BUSINESS (taken out of order):

MASC Annual Meeting 2017 - Update: Mr. Francomano, Mrs. McEntee and Mr. Killion

Mrs. McEntee said that Bill Daggett, who presented at the MASC Conference, would be a good speaker to have to get the community involved as he is an educational researcher, with a focus on Rigor and this may be a way to get everyone involved, succinct of what we are trying to do.

Mr. Francomano agreed that educating the community on the status of public education and the challenges of public education. It was suggested that following the CWG presentation on February 5, the School Committee can talk strategically on next steps. Mrs. McEntee will find out the cost and availability of Mr. Daggett. Once this information is received, the Committee will bring it back to each of the elementary districts to see if this is something they wish to collaborate on.
