Special Education Review:

Dr. Zielinski updated the School Committee on the special education review and presented the 12 focus questions that will be the focus of the review. The posting of the draft position for the special education review consultant has been posted on School Spring. The superintendents will come back to school committees for their recommendation on who would be a good fit to do this work.

Mr. Francomano noted that this posting is very generic. Dr. Zielinski explained that this was the initial draft. The postings on School Spring, CASE and ACE are more detailed. It has also been sent to local colleges for professors who do this type of work. Consulting firms in this area may also apply. The approximate cost is expected to be in the \$10,000-15,000 range for the consulting fee (divided by 4 districts).

The final enrollment figures for October 1, 2015 have been determined, with an additional 40 students more than projected according to Dr. Zielinski.

REPORTS AND RECOMMENDATIONS OF THE SUPERINTENDENT:

Taken from Late Communication – Cleaning Effort – HS:

In a memorandum dated November 1, 2015, Mr. Schaefer explained the process that has been taken to disinfect the high school based upon two confirmed cases of MRSA. Dr. Zielinski explained that there is no reported link between the students and no confirmation that the students contracted MRSA from being in the HS building. However, the district is taking this matter very seriously and the lockers rooms, equipment, and the areas frequented by students have been sanitized. Affected students are being monitored by school nurses.

Dr. Zielinski indicated that the two students diagnosed with MRSA are being monitored by the school nurse, under doctor's care and are taking antibiotics; they are back in school. She noted that the doctors are responsible for notifying the DPH that MRSA has been diagnosed.

Discussion ensued on the cost of disinfecting the HS. Mr. Schaefer indicated that all time spent will be on time cards. Carpet cleaners and the plumbers, as well as any cleaning agents used will be combined for a total. Proposals received for outsourcing this work ranged from \$65,000 to \$205,000. The custodial crews from the MS and the HS cleaned the building and the maximum overtime would be approximately \$8500.

The school committee asked that Dr. Zielinski send a ConnectEd message to the community and attach Mr. Schaefer's memo and to also indicate that the CDC and DPH protocols are followed. Discussion ensued on the MRSA outbreak in other schools and resources that are available on the Internet.

Each executive board member attended several different workshops lead by presidents of other councils within SEMASC, and were given the opportunity to hear from keynote speaker, Jessica Funk; who shared her story regarding her declining of 3 record deals, and the pressure you can undergo from society.

School Committee Goals were tabled.

Meeting of the Chairs: Mrs. Martin

On October 21st, the first meeting of the Chairs of the 2015/2016 School Year was held. In attendance were Ann-marie Martin, KP Chair, Linn Caprarella, Plainville Chair and Tracey Murphy, Wrentham Chair. The Norfolk Chair was

unavailable that evening. The meeting was informal, just a welcome back, and discussion of what is going on in the districts.

The discussion began with the Special Education Review. The superintendents met on October 27th and the Chairs are excited to see the collaboration happening in all 4 districts and look forward to continued cooperation as this process moves forward.

Discussion was held on the system-wide school committee meeting – potentially happening after the holidays. Mrs. Martin had an informal conversation with Representative Dooley and Senator Ross during the Plainville *Walk to School*. They both expressed a willingness to be involved. As the result of several sessions Mrs. Martin had attended at the MASSCue Conference earlier in the day, she also brought up the potential of looking at discussing how each District handles Digital Citizenship throughout a student's education. Everyone was receptive to looking at this as well.

Mrs. Martin updated the group on the KP Turf Field and Track restoration, the 2016 Graduation date and venue change, and discussed the shared services memo sent out by Dr. Zielinski.

Dr. Murphy shared information about the suicide prevention program in Newton Public Schools. Mrs. Martin has shared this information with Dr. Oliviera.

Solar Net Metering by Synergy Energy

Mr. Schaefer explained that the contract is all the same as previously presented except for Section 3.2 on the length of this term. Attorneys agree that it would be 180 days or no later than April 30, 2016. This contract has been vetted by Attorney LeBlanc and he feels that it is permissible for the School Committee to approve this document as it is presented now.

Motion: A Motion was made by Mr. Francomano, seconded by Mr. Killion, that the King Philip Regional School Committee approves the entering into a Net Metering Credit Purpose and Sale Agreement with Synergy Energy, LLC., for the purpose of purchasing and receiving net metering credits associated with energy generated by the facility for an aggregated capacity of 3,600 KW-AC (thirty six hundred kilo watts alternating current), and further That the King Philip Regional School Committee authorizes the Superintendent of Schools to execute said agreement. All in favor.

Mrs. Schmitz would like to share this with Wrentham. Mr. Schaefer will ask that Mr. Jenkins of Synergy Energy contact the 3 town administrators of Norfolk, Plainville and Wrentham.

NEW BUSINESS (continued):

Quarterly Report:

Mr. Schaefer presented the Quarterly Financial Report. There were no reflections of changes to transfer the line items around, but wanted to wait until we have an agreement with the Association on their collective bargaining agreement.

Discussion was held by the Finance Subcommittee on Table 5, the Fund 60 lost books there was a conversation about using that money for its purpose and zeroing out that account. There was also discussion on Fund 53, DECA account. There is concern that the FY15 actual balance of \$10,780 which has grown from FY14 should be used to offset expenses for the cost of the trips which doesn't appear to have happened in FY15. Further clarification was asked for as part of an upcoming DECA discussion.

Fall town meeting warrant articles:

Mr. Francomano asked if written confirmation from both towns that the language has been reviewed and is acceptable? Mr. Schaefer will follow up with both Norfolk and Wrentham.
