**Reports and Recommendations of the Superintendent (Taken out of Order):**

Ms. Lacher, Director of Special Education, introduced Erin Monnell, the HS Special Education Adjustment Counselor. Ms. Monnell is in her third year at the High School and recognized that there is a great need at the High

School for services for students who have academic, social, emotional and short-term medical needs or who have a short-term need for some type of support such as a transitional program.

Ms. Monnell received a grant in the amount of \$73,000 from the MetroWest Health Foundation to start a Transitional Program at the High School. During a PowerPoint presentation, Ms. Monnell gave an overview of the program and the services that will be provided. The referral process and the protocol that will be followed were explained.

Discussion ensued on the funding of the program for the second year if the grant was not funded. She explained that the District would need to find funding from another source or discontinue the program. Ms. Monnell explained that detailed data will need to be kept to show what the program has done for our students and there will be a lot of information on which to make a recommendation. This grant is a 12-month funded program from January 2015 to January 2016.
