**FY22 SCHOOL CHOICE PUBLIC HEARING – 7PM:**

Mr. Gee opened the FY22 School Choice Public Hearing at 7pm.

Mr. Gee asked for comments from the public, hearing none, Mr. Zinni recommended that the District move not to participate in School Choice for FY22 due to the current enrollment within the District. A Motion was made by Samad Khan, seconded by Trevor Knott.

Discussion ensued on how the determination is made to set a cap for class size and financial implications.

The motion was brought forward:

-  **A Motion was made by Mr. Khan, seconded by Mr. Knott, that the District not participate in School Choice for FY22 due to the current enrollment in the King Philip Regional School District. All in favor: Yes (8); No (0); Abstain (0). 8-0-0 Motion carried.**

Mr. Gee closed the Hearing at 7:10pm.

A Recess was taken at 7:25pm and the meeting reconvened at 7:30pm.

### REPORTS AND RECOMMENDATIONS OF THE SUPERINTENDENT

#### *U.S. News & World Report: Education 4/27/21- KP High School National Ranking*

King Philip rated in the top 12% in the Country and top 24% in the State according to the U.S. News & World Report - Education dated 4/7/221. Mr. Zinni explained that Massachusetts outperformed the country and KP consistently outperforms the state. Discussion ensued on comparison scores from last school year. Mr. Zinni will look into additional data and report back to the school committee at a later date.

#### District Update:

#### School Committee Retreat:

Mr. Zinni is coordinating with the three elementary districts to have a full-day School Committee Retreat with the 4 districts, tentatively scheduled for Thursday, July 22. More details will be provided as they become available. Mr. Zinni has invited Anthony Bent to be a guest speaker at the retreat.

#### Finance Subcommittee Meeting:

The Finance Subcommittee along with Mr. Zinni and Mr. Azer will hold a meeting on Monday, May 24 at 7pm in the HS Library. Mr. Zinni has invited all members of the KP School Committee to attend this meeting on a voluntary basis to review the budget and to support new members and explain the budget process. The Norfolk Town Meeting will be held on Saturday, May 8; Plainville and Wrentham town meetings will be held on Monday, June 7.

#### National School Nurses and Teacher Appreciation Week.

Mr. Zinni recognized the district's school nurses and KP teachers. They are the most dedicated and tremendously talented staff according to Mr. Zinni.

#### MS Reopening:

- Mr. Zinni reported that the MS had a good first week.
- End of day dismissal was reviewed. Mr. Zinni is asking that families please utilize bus transportation. Safety is a priority for our students.

#### HS Update:

#### Updates quarantine and covid contact tracing:

An update was sent to all families regarding new guidelines on quarantining and contact tracing.

### **Survey Information:**

Any student who has been remote at the high school was asked to let us know by the end of the day on Wednesday, 4/27/21 what their intentions were for the remainder of the year. A little over 100 students have informed us that they will be returning to in-person learning on Monday, while approximately 250 will stay remote. The HS administrative team reviewed this information and hand scheduled every class and every lunch for room capacity over the weekend.

Dr. Mobley announced at the Senior Picnic that all seniors would be able to continue to remain in school five days per week. It was also determined that juniors would also be able to be accommodated to stay in school 5 days per week. Some classes may still need to run an A & B cohort if there are too many in a particular class and on the alternate day, students would report to the wood gym or another location to accommodate that class. However, all juniors and seniors would stay in the building through the end of the year.

Mr. Zinni and the administration are continuing to work with families and students who are dealing with social emotional issues.

### **Graduation with Distinction:**

Mr. Zinni was part of the panel of judges on the Graduation with Distinction for STEM and Liberal Arts Tracks. He was very impressed with the work of the students as presented their thesis work.

### **Graduation Update:**

- DESE provided graduation guidance last week. The Administration decided to have outside graduation again this year on the Turf Field. This will accommodate all of the graduates and their guests for a total of approximately 1000 people. Everyone will be socially distanced; masks will be worn, and graduation diplomas presented. Each family will receive 2 guest tickets. Graduation will be held on June 4, with rain dates on June 5 and June 6.
- Dr. Mobley will be holding a Town Hall sometime over the next few weeks for seniors, with more details on graduation and a number of special activities to be planned.

### **MCAS UPDATE:**

Mr. Zinni reported that MCAS will be held. The challenge at both buildings is to find classrooms and staff to monitor the testing. Dates have been set and have been posted in the principal newsletters.
