### **REPORTS AND RECOMMENDATIONS OF THE SUPERINTENDENT**

Dr. Gilson invited Dr. Mobley to speak on behalf of the accomplishments of the wrestling team and the US Veterans Motorcycle Club Representatives. (taken out of order)

Dr. Mobley reminded everyone that this week is teacher appreciation week. Teacher's would love to hear from the people that represent our communities. Dr. Mobley said any good wishes can be emailed to her at [mobleyl@kingphilip.org](mailto:mobleyl@kingphilip.org) and she will pass the messages on to the faculty.

Dr. Mobley said the KP Wrestling Team is an amazing group of young people. Each year they chose a Veterans organization to support and fundraise for in order to give back to our Veteran community. This year they selected USVMC. As a result of the charity work the team has done, the USVMC has decided to present a scholarship to a King Philip student. Dr. Mobley congratulated Coach Adams on his 200th win. Dr. Mobley introduced Coach Adams, Assistant Coach Poirier, and President Vachon. Coach Adams has entered his 23rd year as a counselor for King Philip School District and 10th year as head coach of KP Wrestling. Assistant Coach Poirier has been in the classroom and on the mat for 8 years. This year's program is the largest they have had in history, the youngest, and the most diverse. Coach Adams introduced each member of the King Philip Wrestling Team and recognized each of them with a certificate.



Coach Adams also recognized Coach Cloutier, Coach Butler and Mrs. Adams. The team has a very strong core value belief system and civic action is important to them in particular affinity for veterans in which Coach Adams is one. Coach Adams presented the USVMC with a plaque that details the wrestling team's accomplishments this year and gave a donation to the cause generated by the wrestling team's young men and women. President Vachon presented the KP Wrestling Team with a certificate of appreciation for the wrestling team's donations. Donations like this help the USVMC to allow them to do their mission. 100% of donations go back out to their veteran community. President Vachon thanked everyone for their support. Mr. Lehan thanked Coach Adams, the KP Wrestling Team and the USVMC Representatives.

### **NEW BUSINESS:**

#### **2023-2024 Student Handbook changes (1st read) taken out of order**

Dr. Mobley explained the handbook policy change regarding athletic transportation language needed to be aligned with both the coach's handbook along with the district handbook. A copy of Dr. Mobley's handbook changes for 23-24 is attached to these minutes. Mr. Cates recommended that since this is the first reading and since it affects the community, he would like to not vote on this tonight and would like to have time for feedback if any. Mr. Wehmeyer asked that the language be clarified about the exceptions that can and cannot be made. Dr. Gilson said they will contact the attorney on how to revisit this. Mr. Lehan asked Dr. Mobley if the wording "injury, medical or family" would do? Dr. Mobley will clarify this language and bring this change back to the committee for a second read.

Dr. Gilson extended her professional congratulations to Dr. Mobley on her new appointment as executive director of the Advanced Math and Science Public Charter School District. Dr. Gilson has worked with Dr. Mobley for 15 years and you can see through her enthusiasm that she has been a champion for the King Philip School District. Dr. Gilson said she will do very well in her new role and will be missed greatly. Mr. Lehan and the committee applauded Dr. Mobley for all of her hard work. Dr. Mobley thanked Dr. Gilson and the committee for their kind words.

#### **KPRHS Jazz Ensemble Overnight Field Trip Request**

Mr. Joshua Wolloff gave a brief overview of the KPHS Jazz Ensemble overnight field trip to Camp Mataponi in Naples, ME. Mr. Wolloff is looking for approval from the committee for this trip. This trip is a traditional trip and has been going on for a long time. Their fees change from year to year. This is funded by the students themselves. The approximate cost of the field trip is around \$500 this year. No student is ever turned away.

#### **FY 2024 Marching Band Fee**

Mr. Joshua Wolloff gave a brief overview of the FY2024 Marching Band Fees. There is an increase in fees every year depending on the number of students. The cost is approximately \$530 this year. Again, no one is turned away.

- **A Motion was made by Mr. Harmon, seconded by Mr. Greaney, to approve a fee of \$530 for the FY2024 marching band program. All in favor: Yes (9); No (0); Abstain (0). Motion carried: 9-0-0.**

**Superintendent Reports and Recommendations:** (continued)

Dr. Gilson recognized the DECA efforts at the international conference held in Orlando, FL. There were 58 students who represented King Philip. Some of these students earned “the glass” trophy. These trophies are displayed in the main lobby. Ms. Abby Hoyt was recognized for first place trophy presented “A Start Up Business Plan”, Phil Harmon and Liam Hickey were recognized for second place in their financial literacy project. Luke Anderson and Ryan Taylor were recognized for third place for their independent business plan. KP DECA was the only chapter in the state that won first place trophy for the large contingent that went and did so well. Trinjan Kaur was elected the North Atlantic region vice president of DECCA and will be in the role next year. Dr. Gilson thanked Mr. Dow being the DECA advisor and supporter of all of DECA student accomplishments.

Dr. Gilson mentioned that there was an event on Saturday, May 6th, called “Saturday School for Parents” hosted for KP for all in the tri-town community. Several organizations were present such as Families for Depression Awareness, Healthy KP, and the parents/community members led by our Diversity, Equity, and Inclusion Director that was there to share information about the community book read “How to Raise An Anti-racist.” Ms. Dot Pearl, Wellness Director for the district is looking at how to bring different stakeholder groups to connect with the information that would help students prevent substance abuse, mental health issues, along with many other issues that are challenging to parents of today.

Dr. Gilson said there were two professional development sessions held last week. The middle school is working on PBIS-Positive Behavior Intervention Systems. They have been working on designing a school wide positive plan for the behavior at the middle school. At the high school they are continuing to develop the Vision of a Graduate and link this vision to specific performance outcomes. The Vision of a Graduate deals with six levels: think, accept, innovate, communicate, contribute and learn. These categories emerged from a process in 2021-2022 where information was gathered from many different stakeholders. They are important because they highlight our expectations for student experiences at King Philip along with what is an expected part of the accreditation process. We will have a site visit next year from NEASC as part of the high school accreditation process.

Dr. Gilson said Career Day on April 26th was very successful. There were organizations that were represented that will help students launch careers immediately after graduation. There were stem based companies, business organizations, training institutes, and health based organizations. It was a very well attended event.

Dr. Gilson thanked Mr. Shaughnessy for the Stuco Report. She also said the performance of Chicago was outstanding this weekend as put on by our King Philip students.

We have one policy change regarding athletic transportation.

**Proposed Text (NEW)**

When traveling to an activity or event with members of the group, these guidelines must be followed.

- A. Behavior should be professional
- B. Dress should be neat
- C. Participants must ride to and from the facility (athletic or general) on the bus with the advisor/coach or chaperone.
- D. A written request and prior approval of the advisor or coach (for athletics), except in the case of injury or medical emergency, is required if the student is not able to ride to or from the facility on the bus.
- E. A coach may allow students to ride home from a contest with their parents or guardians, provided permission has been granted at the game site. This is an exception and may be granted sparingly.
- F. Students wishing to drive to and from an activity need to provide parental/guardian approval in writing to the advisor or coach (for athletics)

G. Students are not allowed to leave or get a ride from an adult who is not their parent/guardian or another student.

**Text from Student Handbook (page 115) OLD**

7. When traveling to an activity or event with members of the group, these guidelines must be followed:

A. Behavior should be professional

B. Dress should be neat

C. Participants must ride to and from the activity (athletic or general) in the bus with the advisor/coach or chaperone; no exception can be made without a written request and prior approval of the advisor or administrator except in case of injury or medical emergency
